Dear Shareholder,

We refer to the Shareholder Notice dated 14<sup>th</sup> February 2024 where you have been advised of the forthcoming implementation of new screens in the indices being tracked by the above listed Index Equity Funds and the resulting update of the names of the indices tracked by these Funds, effective from the 1<sup>st</sup> June 2024.

We are writing to advise you that the updated MSCI Indices names included incorrect reference to the word “Select”. Effective from the 1st of June 2024, the correct updated benchmark names should read as follows:

The above corrections will be reflected in the prospectus of the Fund (the “**Prospectus**”).

Any costs incurred in relation to the correction of the selected MSCI Indices names in the Prospectus will effectively be borne by the Management Company, as the Sub-Fund’s expenses already exceed the Maximum TER detailed in the Prospectus.

For the avoidance of doubt, capitalised terms used in this notice shall bear the same meaning set out in the updated Prospectus.
